# CapitalVest Terms and Conditions of Service

BY ACCESSING OR USING ANY PART OF THE CAPITALVEST SERVICE, YOU AGREE TO BE BOUND BY THESE TERMS. IF YOU DO NOT AGREE TO ALL THE TERMS AND CONDITIONS OF THIS AGREEMENT, DO NOT USE OR ACCESS THE SERVICE.

## 1. Description of Service

CapitalVest provides an automated, technology-driven investment platform that utilizes proprietary algorithms, including the **Behavioral-Quant (B-Q) Engine**, to offer portfolio construction, rebalancing, and behavioral nudges designed to promote long-term investment discipline.

#### 1.1. Nature of the Service

Our service provides **algorithmic investment recommendations** based on the financial information you provide. **CapitalVest IS NOT a provider of personalized financial planning or individualized tax advice.** All investment decisions remain solely your responsibility. The B-Q Engine's "Behavioral Shield" features are tools to mitigate emotional biases and do not constitute a guarantee of positive returns or protection against loss.

## 1.2. Investment and Custody

All securities transactions and custody of assets are managed through our regulated partner clearing brokers and custodians, which will be disclosed to you upon account opening.

# 2. User Eligibility and Account Requirements

### 2.1. Eligibility

You must be at least eighteen (18) years of age, or the age of majority in your jurisdiction, and have the legal capacity to enter into a binding contract to use the Service. You must also be a resident of a jurisdiction where the Service is legally offered.

## 2.2. Account Information and Security

You agree to:

1. Provide accurate, current, and complete information during the registration process and keep this information updated.

- 2. Maintain the confidentiality of your account credentials (username and password).
- 3. Immediately notify CapitalVest of any unauthorized use of your account.
- 4. Be fully responsible for all activities that occur under your account.

#### 3. Risks and Disclosures

#### 3.1. General Investment Risk

CapitalVest charges an annual, assets-under-management (AUM) advisory fee, as detailed in the separate **CapitalVest Fee Schedule**. This fee is typically calculated daily and charged monthly or quarterly.

## 4.2. Brokerage Costs

You are responsible for paying any transaction costs, brokerage commissions, or regulatory fees incurred through our third-party custodians or brokers.

### 4.3. Reporting

CapitalVest will provide periodic statements detailing account activity, portfolio holdings, performance, and fees, in compliance with applicable regulatory requirements.

software, trade secrets, and intellectual property, are the exclusive property of CapitalVest and its licensors.

- Use any robot, spider, or other automated means to access the Service for any purpose without our express written permission.
